# MGPS Preapproved Specialization Courses for Spring 2017

### **Updated 14 October 2016**

### \*\* IMPORTANT NOTES \*\*

- Please note that <u>this is not a comprehensive or final list</u>. Please check the Registrar's site for updates and crosscheck unique numbers before registration.
- Courses must have sufficient <u>international and policy relevant content to count</u>. Foreign language and other skills-oriented classes (i.e.: those without a substantive focus) do not count towards the specializations, unless they contain at least 50% content (graded material) that has direct relevance to your specialization. These courses are subject to ad hoc approval by the specialization coordinator and the GPS Advisor.
- There are several courses at LBJ and around UT whose titles do not obviously fit with the MGPS specializations. However, the GPS Advisor may consider approving these courses on an ad hoc basis, if at least half of the course grade is determined by work that has direct relevance to your specialization. You must prove this both before signing up for the course (by confirming that 50% of your grade will be relevant to your specialization, and making sure this fits the course requirements in the syllabus) and after you complete the course (by turning in the work after the course is over to seek approval from the GPS grad advisor to apply the course to your specialization).
- If you are considering taking **classes in another department**, please:
  - Check prerequisite requirements (especially important for business school and economics);
  - Check to see if permission of instructor is needed prior to registration;
  - Ocheck if it's a Law School class—if so, there is paperwork involved: please see your GPS grad advisor;
  - o Check for registration restrictions: most courses in other schools and departments are restricted for three days during registration. Keep this in mind when planning your schedule.
- Please note that the <u>PA188G one-credit courses are all scheduled to meet at the same time</u> (even though they meet in different weeks), so you will need to fill out a time-conflict override form to register for more than one of them. These forms are available outside your GPS grad advisor's office.
- Reminder: you will need to complete 15 credit hours' worth of coursework in your field of specialization for your LBJ degree, whether or not you are a dual degree student. Only graduate-level courses may count toward your GPS degree.
- All of you who are currently in a PRP must register yourselves for the second half of the same PRP section
- For all of you with custom specializations, please consult with Dr. Redei before assuming that any course would count toward your self-designed specialization.
