RBJ Center Seeks Master Developer for East Austin Property

Austin, Texas: The Austin Geriatric Center (AGC), Inc. also known as the Rebekah Baines Johnson (RBJ) Center, a local 501c3 committed to providing affordable housing for seniors announced today the release of a Request for Qualifications (RFQ) for a master developer for the 18-acres of prime real estate owned by AGC located in central East Austin along Lady Bird Lake. In November 2011, the RBJ Center Board of Directors approved a redevelopment master plan vision that would allow for a vibrant, urban village containing a variety of potential land uses that would accommodate both the needs of our senior citizens and area neighborhoods and residents. To achieve this goal, AGC is seeking a partner and Master Developer to facilitate our redevelopment vision. The RFQ/RFP solicitation will be a two-step evaluation process, involving the development of a shortlist based upon the statements of qualifications submitted. Firms that are shortlisted will be invited to formally submit business and development proposals. AGC plans to announce the successful Master Developer by July 2013.

"Rebekah Baines Johnson Center is moving forward with its plan to construct additional independent living units for low income seniors at its existing 18 acre campus on Lady Bird Lake and to renovate our existing 16-story tower. We are seeking a well qualified development partner who can acquire some of our land and help us to develop the rest, all in accordance with the strategic master plan we have put together in concert with our neighbors, the City of Austin and our Strategic Planning Committee" said Clarke Heidrick, Chairman of the AGC Board of Directors.
