Complex Organizational Problems

Issues facing corporate, government and not for profit organizations and institutions of higher education are extremely complex, and yet we are often surprised when solutions and decisions for these issues fail to "solve" the problem. Indeed, we all know of cases where the solution actually made the problem worse! Standard problem-solving/decision-making models are useful for addressing certain types of issues, but are often inadequate, by themselves, for effectively addressing more complex issues.

This two-day workshop is designed for managers and leaders who wish to use the tools and processes of systems thinking to enhance their own thinking and to better understand, assess and address complex organizational problems.

Learning Outcomes

By the end of this course, participants should be able to:

- · Understand the basic principles of systems thinking
- Apply these principles in better understanding organizational issues and problems
- Diagram moderately complex organizational issues to better understand behaviors and what drives them
- Follow a step by step process for applying systems tools in organizational problem solving
- Understand how systems tools can be employed in managing organizational change and strategic planning

Real-World Applicability

To provide immediate application of the principles learned, in class exercises will involve participants using systems thinking tools to analyze organizational issues each will bring to class. Each participant should identify an issue with which they are involved that meets the following criteria: it is a current issue that is strategic in nature, efforts to address the issue have not been completely successful, and you have some influence over/responsibility for solutions considered.
